

# Energy Education for Michigan, Inc. – Tony Howard Scholarship 2012-2013 APPLICATION

The Energy Education for Michigan, Inc. (EEM) – Tony Howard Scholarship Fund was established in 2010 to provide scholarships to students actively seeking degrees in programs relating to future careers in the crude oil and natural gas industry at postsecondary Michigan Educational Institutions. The scholarship is named in memory of Charles P. “Tony” Howard (of Kalkaska) whose career in the oilfield spanned 52 years, starting in the oil patch right out of high school.

Applicant criteria: must be a Michigan resident; must demonstrate financial need; must have a minimum 2.5 GPA (calculated on a 4.00 scale); must be a full-time student in good standing at a postsecondary, accredited Michigan “Educational Institution” at the time the award is paid (an “Educational Institution” is an organization that normally maintains regular faculty and curriculum and has a regularly enrolled student body in attendance); must be enrolled in a course of study which will allow for full time employment in the crude oil and natural gas industry.

The scholarship with a minimum of \$500 will be paid to the postsecondary institution where the applicant is enrolled and mailed to the applicant at the address provided. The scholarship may be renewable on an annual basis. **It is the responsibility of the initial award recipient to submit the Annual Renewal Application each year (up to 3 years or until a Bachelor’s Degree is earned, whichever occurs first). Applications for renewal will be reviewed on a case-by-case basis. Renewal is not guaranteed.**

Completed applications must be received at the office of Energy Education for Michigan, Inc. on or before **July 16, 2012**. **All information must be complete; illegible or incomplete applications will not be considered.**
